## ANNOUNCEMENT OF FINAL ALLOTMENT RESULTS

## **SUMMARY**

- This announcement sets out, among other things, the final level of valid applications in the Hong Kong Public Offering and the CNT Preferential Offer which have been validly confirmed by the Eligible Hong Kong Applicants and the Eligible CNT Applicants, respectively, and the final level of interest in the International Offering, and the despatch arrangements for refund monies with respect to unconfirmed applications.

### **The Supplemental Prospectus and revised expected timetable for the Global Offering**

- On 29 June 2017, the Company announced, among other things, the final Offer Price, the level of valid applications and the basis of preliminary allotment in the Hong Kong Public Offering and the CNT Preferential Offer and the level of interest in the International Offering.

On 30 June 2017, the Company announced the publication of and published the Supplemental Prospectus, which sets out the details and status of the Petition. As of the date of this announcement, the Directors understand that there is no update to the Petition filed by Chinaculture.com against CNT and Prime Surplus. The Supplemental Prospectus also sets forth the revised expected timetable for the Global Offering as well as the requirement for Eligible Applicants to confirm their applications for the Hong Kong Offer Shares and/or the CNT Reserved Shares before the deadline specified in the Supplemental Prospectus. Eligible Applicants who wished to proceed with their applications for the Hong Kong Offer Shares and/or the CNT Reserved Shares were required to submit the completed **WHITE** and/or **BLUE** Confirmation Forms during the period from 9:00 a.m. to 5:00 p.m. on Monday, 3 July 2017 to Wednesday, 5 July 2017.

### **Offer Price and Use of Proceeds from the Global Offering**

- Based on the Offer Price of HK\$0.86 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%), the net proceeds from the Global Offering to be received by the Company, after deducting the underwriting fees and estimated expenses payable by the Company in connection with the Global Offering, are estimated to be approximately HK\$175.4 million. The Company intends to apply such net proceeds for the purposes as set out in the section headed “Future Plans and Use of Net Proceeds from the Global Offering” in the Prospectus.

**Results of valid applications which have been validly confirmed by the Eligible Applicants under the Hong Kong Public Offering and/or the CNT Preferential Offer**

**(a) Hong Kong Public Offering**

- Based on the total number of 25,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering (before re-allocation), the shares offered under the Hong Kong Public Offering have been moderately over-subscribed. Out of the original 9,784 valid applications, a total of 5,446 valid applications for a total of 86,404,000 Hong Kong Offer Shares, have been validly confirmed by the Eligible Hong Kong Applicants, representing (i) approximately 69.12% of the total number of 125,000,000 Hong Kong Offer Shares initially allocated under the Hong Kong Public Offering (after re-allocation; (ii) approximately 3.5 times of the total number of 25,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering; and (iii) approximately 34.56% of the Offer Shares in the Global Offering (before the exercise of Over-allotment Option).

**(b) CNT Preferential Offer**

- Out of the original 37 valid applications, a total of 10 valid applications for a total of 21,693,458 CNT Reserved Shares have been validly confirmed by the Eligible CNT Applicants, representing (i) approximately 86.77% of the total number of 25,000,000 CNT Reserved Shares initially available under the CNT Preferential Offer; and (ii) approximately 8.68% of the Offer Shares in the Global Offering.

**Level of Indications of Interest in the International Offering**

- Taking into account all valid **WHITE** Confirmation Forms received from Eligible Hong Kong Applicants, 38,596,000 unconfirmed Hong Kong Offer Shares have been allocated to the International Offering.
- Taking into account all valid **BLUE** Confirmation Forms received from Eligible CNT Applicants, 3,306,542 unconfirmed CNT Reserved Shares have been allocated to the International Offering.

- The Offer Shares initially offered under the International Offering have been moderately over-subscribed. Taking into account the re-allocation of 38,596,000 unconfirmed Hong Kong Offer Shares under the Hong Kong Public Offering to the International Offering and the re-allocation of 3,306,542 unconfirmed CNT Reserved Shares under the CNT Preferential Offer to the International Offering, the final number of Offer Shares under the International Offering (including the 21,693,458 CNT Reserved Shares) is 163,596,000 Offer Shares, representing approximately 65.44% of the Offer Shares available under the Global Offering (before the exercise of Over-allotment Option).

A total of 44 placees have been allotted one board lot of the Offer Shares, representing 24.04% of the 183 placees, being the total number of placees under the International Offering (excluding the CNT Reserved Shares under the CNT Preferential Offer). These placees have been allotted approximately 0.12% of the International Offer Shares under the International Offering (excluding the CNT Reserved Shares under the CNT Preferential Offer).

- In connection with the Global Offering, the Company has granted the Over-allotment Option to the International Underwriters, exercisable by the Stabilising Manager, on behalf of the International Underwriters, from the Listing Date until Sunday, 23 July 2017, being the 30th day after the last day for the lodging of applications under the Hong Kong Public Offering, to require the Company to allot and issue up to an aggregate of 37,500,000 additional new Shares, representing 15% of the Offer Shares initially available under the Global Offering at the Offer Price to cover over-allocations, if any, in the International Offering. No over-allocation of Shares was made in the International Offering and there will not be any stock borrowing arrangement under the Stock Borrowing Agreement entered into between the Stabilising Manager and CNT Enterprises Limited for the purpose of covering over-allocation. As of the date of this announcement, the Over-allotment Option has not been exercised. It is expected that the Over-allotment Option will not be exercised. In the event the Over-allotment Option is exercised, an announcement will be made on the Company's website at [www.cpmgroup.com.hk](http://www.cpmgroup.com.hk) and the Stock Exchange's website at [www.hkexnews.hk](http://www.hkexnews.hk).

- The Directors confirm that no Offer Shares under the International Offering have been allocated to applicants who are core connected persons of the Company, the Directors, the existing Shareholders or their respective close associates within the meaning of the Listing Rules whether in their own name or through their nominees and the International Offering is in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules. The Directors confirm that no placee will, individually, be placed more than 10% of the enlarged issued share capital of the Company immediately after completion of the Global Offering. The Directors confirm that none of the Sponsor, the Joint Global Coordinators, the Joint Bookrunners, the Joint Lead Managers and the Underwriters and their respective affiliated companies and connected clients (as defined in Appendix 6 to the Listing Rules) have taken up any Offer Shares for its own benefit under the Global Offering. The Directors confirm that there will not be any new substantial Shareholder immediately after the Global Offering within the meaning of the Listing Rules and the Company's public float will satisfy the minimum percentage prescribed by Rule 8.08(1) of the Listing Rules. The Directors confirm that the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules.
